GLENDALE FAMILY BICYCLE RIDE APPLICATION AND RELEASE

Please accept my application for the City of Glendale's GLENDALE FAMILY BICYCLE RIDE ("Event").

I ACKNOWLEDGE THAT BY SIGNING THIS DOCUMENT I AM RELEASING THE CITY OF GLENDALE, ITS EMPLOYEES, ELECTED OFFICIALS, AGENTS, SPONSORS, PROMOTERS OR AFFILIATES ("Sponsors") FROM LIABILITY CONNECTED WITH THIS EVENT. I UNDERSTAND THAT THIS APPLICATION AND RELEASE IS A CONTRACT WITH LEGAL CONSEQUENCES.

In consideration of the Sponsor's acceptance of my application for the Event, I hereby understand and agree or assert:

That cycling can be a dangerous sport and that I fully assume the risks, including, but not limited to: collision with pedestrians, other participants, vehicles or fixed or moving objects; surface hazards or weather conditions; the risk of serious physical injury or otherwise; and that I have no physical or medical condition, which to my knowledge, would interfere with my ability to participate or would endanger myself or others.

That it is my responsibility to be familiar with the Sponsor's rules, and any special regulations for the Event; that situations may arise that may be beyond the control of Event officials and that my continued participation in the Event must neither endanger myself nor others; and that I will wear a helmet during the Event and accept responsibility for the condition and adequacy of all my equipment, including the helmet.

As a participant, or parent/legal guardian of a participant, I/we hereby release and forever discharge the City of Glendale, its elected and appointed officials, directors, officers, boards, commissions, agents, representatives, servants and employees and any and all other sponsors, persons, firms, or corporations who are or might be liable, from any and all claims of any kind of character which I/we have or may have against them. This waiver includes all damages, loses, costs, expense and injuries that allegedly occur during the course of this recreation program. In that regard, I/we consent to indemnify, defend, and hold harmless to the fullest extent permitted by law, the foregoing persons and entities from any loss or damages, including reasonable attorney's fees and litigation expenses, which may be incurred by them in the event any such claims are asserted against each or any of them. I/we understand that medical claims are my/our responsibility. Medical insurance is NOT provided by the City of Glendale. This waiver does not extend to any such claim or liability that is caused by the sole and exclusive intentional acts or gross negligence of the City of Glendale or its officers.

I further agree for myself and my Successors that the above representations are contractually binding and that if I or any Successor asserts any claim in contravention of this release, the party asserting the claim shall be liable for all expenses, including legal fees, incurred in defending the claim unless the Sponsor is finally adjudged liable on the claim for willful and wanton negligence; that this release may not be modified orally, and waiver of any provision herein shall not be construed as a modification of any other provision; that every provision of this release is intended to be severable and if any other provision is found to be unenforceable that the remaining provisions shall remain binding and enforceable.

In addition, I give the City of Glendale, Arizona permission to use my name, likeness, image, and/or appearance as such may be embodied in any pictures, photos, images etc., taken or made by or on behalf of the City of Glendale in conjunction with the Glendale Family Bike Ride. I agree that the City of Glendale has complete ownership of such pictures, photos, images, etc., including the entire copyright, and may use them for any purpose consistent with the City of Glendale's mission. These uses include, but are not limited to advertisements, publications, illustrations, bulletins, exhibitions, reprints, reproductions, and any promotional or educational materials in any medium now known or later developed, including the Internet. I acknowledge that I will not receive any compensation for the use of such pictures, photos, images, etc., and here by release the City of Glendale and its agents and assigns from any and all claims which arise out of or are in any way connected with such use.
