Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

Applicability. The Form HUD-50075-ST is to be completed annually by **STANDARD PHAs or TROUBLED PHAs**. PHAs that meet the definition of a High Performer PHA, Small PHA, HCV-Only PHA or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

If using Project-Based Vouchers (PBVs), provide the projected number of project-based units and general locations, and describe how project basing would be consistent with the PHA Plan.</p> <p>PROJECT BASED VOUCHERS: In December 2022, Glendale Housing Authority (GHA) submitted the AZ003 Project-Based Voucher Program Cap Worksheet to the HUD PBV Submission office and copied to the Phoenix local HUD office. This work sheet specified that up to 140 of the Housing Choice Vouchers would be used for PBV with 120 Regular PBV and 20 in the 10% cap for special populations. GHA received approval. Public Notice was posted on the GHA Website on January 8th, stating GHA was accepting applications for PBV from qualified developers under the provisions of 24 CFR 983.51(b)(2) Selection based on previous competition and listed the requirements and how to apply. The opportunity was also submitted to the City Clerk for publication in the Arizona Republic on February 8, 2023. The PBV Assistance Application contains details about the opportunity including intent to award, review period, project overview, and project ranking criteria. Applications are reviewed and ranked in accordance with the published criteria.</p> <p>To date, two applications have been received for the developments detailed below, contingent PBV award letters were issued allocating a total of 120 PBV, and execution of the required Agreement to Enter into A Housing Assistance Payments (AHAP) contracts are imminent.</p>

Centerline on Glendale

Gorman & Company LLC will serve as the developer for a total of 368 units located on the southeast corner of West Glendale and North 67th avenues, Glendale, AZ 85301. Units will consist of one-, two-, and three-bedrooms serving singles and families. Gorman & Company is a for-profit housing developer with extensive affordable development and management experience having developed over 11,000 units in 140 developments including 1,350 units in 16 projects in Maricopa County. Both phases of Centerline on Glendale will be developed concurrently and will operate as one site with the following resident benefits:

- Additional assisted units from the Arizona Health Care Cost Containment System to serve developmentally disabled residents
- The development will offer direct supportive services to residents on-site including life skills and other programs designed to improve long-term sustainability.
- Amenities include computer room, community space, exercise room, dog park, splash pad, barbecues, ramadas, and walking path.
- Additionally, development includes a unique social enterprises component and partnership with Local First Arizona to create a commercial kitchen for small food vendors looking to improve their product and learn how to build and grow small food businesses. The goal of this facility is to create new small business entrepreneur program that can strengthen low-income families.

Centerline on Glendale – Phase I

- 186 total units
- 40 GHA PBV assisted units, 5 of which will be dedicated to serving homeless

Centerline on Glendale - Phase II

- 182 total units
- 40 GHA PBV assisted units, 5 of which will be dedicated to serving homeless

Glendale Senior Apartments

Mercy Housing will serve as the developer for a total of 148 units located on the northeast corner of West Glenn Drive and North 50th Avenue, Glendale, AZ 85301. Units will consist of one- and two-bedrooms serving seniors with a focus on Veterans and homeless populations. Gorman & Company is a non-profit housing developer with extensive affordable development and management experience having developed over 23,000 units in 336 developments including 700 units in 12 projects in Arizona. The conditional approval is for 40 PBV, all of which will reserved for persons with disabilities or elderly. The development will include the following resident benefits:

- Elevator-served
- Amenities include a community room, laundry rooms on every floor, and a community courtyard
- Collaborative partnerships to provide supportive services to all residents and specifically work with case management providers to serve the permanent supportive housing households and self-sufficiency programs

By leveraging PBV to attract quality affordable housing, GHA and the City of Glendale will accomplish the following:

- Increase the quantity of quality affordable units in the city, currently there are only 779 affordable units in Glendale; 122 units will fulfill their affordability period in 2024 with another 162 units in 2031, leaving only 495 affordable units.
- Encourages capital investment in the city’s identified redevelopment area.
- Supports infill development of underperforming or underutilized parcels within the city.
- Produces quality amenities and wrap-around resident services designed to support low-income households achieve safety and sustainability.
- Creates new jobs in Glendale including one-time construction and ongoing property management and professional services.

Progress Report.

Provide a description of the PHA’s progress in meeting its Mission and Goals described in the PHA 5-Year and Annual Plan.

GHA main goal is to provide safe and affordable housing for eligible families through the Public Housing and the Housing Choice Voucher programs. GHA is funded for helping the Foster Youth kids and now Veterans through the VASH program. The EHV program has been very beneficial for many homeless and at risk of being homeless clients. EHV February numbers reflect the lease-up rate is 86%, the remaining 14% have been issued a voucher and are searching for their home.

GHA continues to provide an improved living environment, by using the Capital Funds wisely and for the needs of the Public Housing community. Listed in B4 are the many projects that have and still being tasked and completed for the well-being of the community.

GHA will partner with and educates landlords. The Community Services Department hired a Landlord Liaison to promote the Housing Choice Voucher program and other housing programs in Glendale. Housing provided the “ A Good Place to Live” packet, handed out the Interested in Becoming a Landlord flyer at community events, provided a sample HUD Housing Choice Voucher Landlord Newsletter to interested prospects at community events. Two of these events were the GAIN event in October and the Stand Up for Vets event in September. GHA teamed up with the Community Revitalization Division in paying an incentive fee to the Landlord for new tenants or tenants who received a non-renewal notice and were forced to find another place to live.

GHA will work toward making Public Housing property as energy efficient and environmentally friendly as possible. GHA is constantly searching for efficient measures for the residents in Public Housing. GHA purchases efficient lightbulbs (LED), filters/aerators for water faucets, energy efficient appliances, electrical panel updates and recently upgrading all of the A/C units for the new federal standards.

GHA will ensure equal opportunity and affirmatively further fair housing. Community Legal Services (CLS) continues to be an advocate and a resource for our clients. All staff of GHA are required to train on Fair Housing.
