

Community Revitalization Housing Rehabilitation Programs

Thanks to the Community Planning and Development (CPD) funding provided by the US Department of Housing and Urban Development (HUD), the City of Glendale offers several programs designed to help low to moderate income Glendale homeowners improve their homes. Several of the services are provided directly by the city, while others are offered through non-profit agencies.

Emergency Home Repair Program

The Glendale Emergency Home Repair Program provides emergency home repair services (repairs that are required to maintain the safety and habitability of the household) to qualified Glendale homeowners.

Home Accessibility Program

This program provides structural and accessibility modifications to homes occupied by persons with disabilities. This program is available to homeowners and renters. The types of modifications allowed are wheelchair ramps, widened doorways, grab bars, and modifications to showers, sinks, and toilets.

Roof Repair/Replacement Program

This program repairs or replaces deteriorated roofs for qualified homeowners. The types of repairs allowed are; deteriorated fascia, shingles, soffits, sheathing, shingle mold and other related roof components. This program is provided as a grant to the homeowner.

Residential Rehabilitation Program

This program gives homeowners the opportunity to rehabilitate their homes. Improvements must meet minimum building codes and improve health and safety of the home. Types of repairs that could be eligible include; electrical, plumbing or mechanical or structural repairs to existing systems. Projects are funded by providing the homeowner a 10-year forgivable/principle reduction loan.

Exterior Rehabilitation Program

The Exterior Program offers exterior painting of the home for qualified homeowners. To qualify for this program, you must have owned and lived in your home for at least one year and meet the general eligibility guidelines of the program. Subject to available funds, front yard drought resistant landscaping may also be included. This program is provided as a grant to the homeowner.

Voluntary Demolition Program

This program provides the opportunity to demolish properties which are dilapidated, beyond repair and/or pose a health or safety risk to the community. The property must generally be located in a low- to moderate-income area. Structures that may be covered by the program are single-family residential properties; multi-family residential properties; commercial properties. Multi-family residential and commercial properties will be required to share the cost of the demolition project in an amount equal to 50% of the project cost. The city reserves the right to deny assistance based on funding, community benefit, or liability issues.



Community Revitalization Housing Rehabilitation Programs

General Eligibility

- 1. The total household income must be within the federal guidelines for low/moderate-income households.
- 2. The property must be located in Glendale.
- 3. The property must be owner-occupied for at least one year prior to application submittal.
- 4. All property taxes and mortgage must be current and paid.
- 5. Property must be insured.
- 6. Cannot have participated in program previously.

Note: Please contact Community Revitalization for program specific eligibility requirements

Do You Qualify?

Your annual GROSS income (before taxes) cannot exceed the amount shown for the family size listed on the left of the table below, in order to qualify for each program.

Note: Must not exceed the liquid asset limit of \$20,000 to qualify for assistance.
