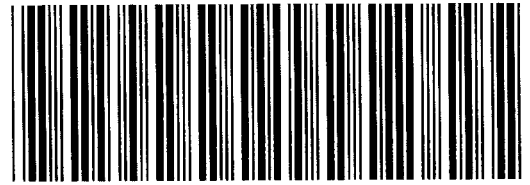

ORDINANCE NO. 2179 NEW SERIES

AN ORDINANCE OF THE COUNCIL OF THE CITY OF GLENDALE, MARICOPA COUNTY, ARIZONA, DEANNEXING CERTAIN REAL PROPERTY, APPROXIMATELY 80 ACRES, LOCATED AT CAMELBACK AND LITCHFIELD ROADS FROM THE CITY OF GLENDALE, CONTINGENT UPON ANNEXATION OF SAID PROPERTY BY THE CITY OF LITCHFIELD PARK, PURSUANT TO THE PROVISIONS OF A.R.S. §9-471.02.

WHEREAS, A.R.S. §9-471.02 provides a method for deannexation of land from one municipality and the annexation to another municipality; and

WHEREAS, it is the intention and the desire of the Mayor and Council of the City of Glendale to deannex certain real property from the City of Glendale so that it may be annexed to the City of Litchfield Park.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GLENDALE as follows:

SECTION 1. That the attached hereto and marked Exhibit "A" is the legal description of certain real property to be deannexed from the City of Glendale.

SECTION 2. That attached hereto and marked as Exhibit "B" is a map depicting the real property described in Exhibit "A".

SECTION 3. That pursuant to A.R.S. §9-471.02(B), the Mayor and Council of the City of Glendale hereby declare the property described in Section 1, Exhibit A is deannexed from the City of Glendale upon the fulfillment of the conditions set forth in A.R.S. §9-471.02.

SECTION 4. That the City Clerk is hereby directed to certify a copy of this Ordinance and file the same with the Maricopa County Board of Supervisors requesting a hearing date as set forth in A.R.S. §9-471.02(D).



FROM THE CITY OF GLENDALE

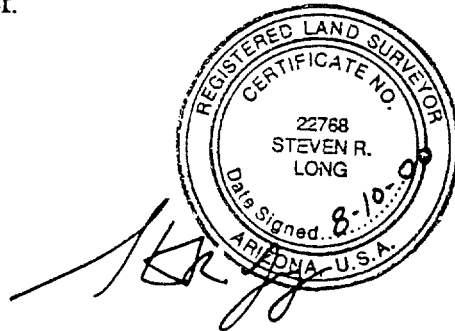
LEGAL DESCRIPTION

Those portions of Section 15 and Section 16, Township 2 North, Range 1 West, of the Gila and Salt River Base and Meridian, Maricopa County, Arizona, described as follows:

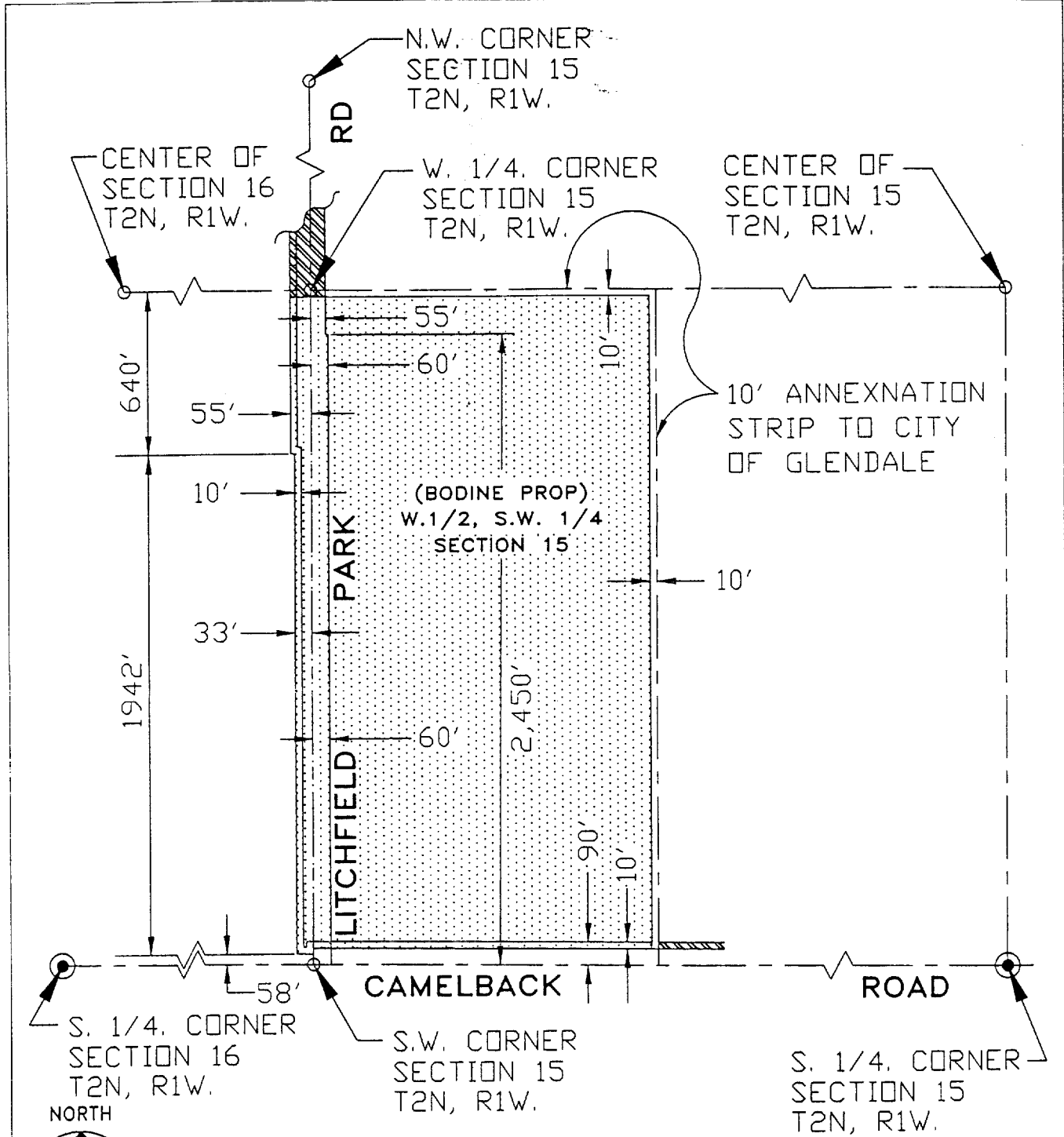
The West half of the Southwest quarter of said Section 15;

ALSO EXCEPT the South 80.00 feet thereof.

EXCEPT the South 58.00 feet and the North 10.00 feet thereof.



The West 22.00 feet of the East 55.00 feet of the North 640 feet of said Southeast quarter of said Section 16;
EXCEPT the North 10.00 feet thereof.
